RULES OF THE "CHRISTOPHER DAVID RYAN FOR MANGO" PRIZE DRAW

1.- GENERAL DESCRIPTION OF THE PRIZE DRAW

The object of the present rules (hereinafter, "the Rules") is to regulate the prize draw organised by the company PUNTO FA, S.L. (hereinafter, "MANGO"), domiciled in Palau-solità i Plegamans (Barcelona), C/Mercaders 9-11, Pol. Ind. 2.- REQUIREMENTS OF THE PARTICIPANTS.

- 2.1 The present prize draw will be held worldwide.
- 2.2 All physical persons of legal age are eligible to enter the prize draw.

3.- PARTICIPATION

- 3.1 The prize draw may be entered by persons who, fulfilling the above requirements, complete the entry form by entering the details (name, surnames, e-mail, mobile phone number, postal code, town/city, gender (M/F)) requested on the microsite www.mango.com/skatecontest, having previously registered on the same.
- 3.2 MANGO will commence the communication for the present promotional activity on 29 July 2015. The entry period will be from 29 July 2015 to 12 August 2015, both dates inclusive. Consequently, only entries received during said period will be taken into consideration.

4.- TECHNICAL REQUIREMENTS

- 4.1 The following will be excluded from the prize draw:
 - a) Any participant who does not complete the aforementioned instructions correctly.
 - b) Any entrant who does not fulfil the participation requirements.
- 4.2 In the selection process of the winners, a maximum of one (1) entry per person and request will be accepted.
- 4.3 MANGO reserves the right to exclude from the prize draw any person who does not comply with the established rules or who does not adopt an honest attitude, in order to guarantee the same rights and opportunities to all entrants.
- 4.4 All participants who have correctly followed the aforementioned instructions, correctly provided the required information and fulfil all the participation requirements for the present prize draw shall be entered on the list of participants eligible to win the prize described below.

5.- SELECTION PROCESS

5.1 MANGO will hold a single prize draw on 13 August 2015 in Palau Solità i Plegamans among the entrants who fulfil the above requirements and will select four (4) participants, who will be declared the winners of the prize draw. Four (4) runners-up will also be chosen and will be eligible for the prize if the first four (4) persons selected are not entitled to the prize on any of the grounds mentioned in the present Rules.

6.- PRIZES

The winners of the prize draw will receive the following prize:

- An exclusive skateboard designed by Christopher David Ryan for MANGO.

7.- NOTIFICATION OF PRIZES TO WINNERS

- 7.1 Two days after the close of the prize draw, MANGO will contact the winners via e-mail, at the address previously provided by the same. The name of the winners may also be published on the webpage www.mango.com, subject to the express acceptance of the same.
- 7.2 Once the notification indicated in clause 7.1 above has been made, the winners must, within a deadline of forty-eight (48) hours from reception of said notification, confirm their acceptance of the prize by e-mail, provide their full name and a copy of their National ID document or passport, and expressly agree to the use of their name and image for advertising purposes, as stipulated in sections 7.1 and 8.6 of the present document. Otherwise, on 17 August 2015 a substitute will be contacted who, within a deadline of twenty-four (24) hours, must accept the prize and provide the required information for the processing of the same. The same procedure will be repeated for the four (4) runners-up.
- 7.3 Following the express acceptance referred to in the above paragraphs, MANGO may announce the name of the winners on its different social network profiles, and on its webpage.
- 7.4 The prize will be delivered by post to the address provided by the winners once they have been contacted.

8.- RESERVATIONS AND RESTRICTIONS

- 8.1 MANGO shall be exempt from any liability in the event of any errors in the details provided by the winners which prevent the same from being identified.
- 8.2 Under no circumstances shall MANGO be liable for services provided to the winners by any other organisation it collaborates with as a consequence of the prize award.
- 8.3 The prize award is personal and non-transferable and may not, under any circumstances, be exchanged, modified or cashed at the request of the winner.
- 8.4 MANGO reserves the right to cancel the prize draw, either permanently or temporarily, in both cases on the grounds of force majeure, unforeseen or unforeseeable circumstances, or fraud.
- 8.5 Mere participation in the prize draw implies full acceptance of the Rules of the same.

- 8.6 MANGO may subject the awarding of the prize to the prior, written and signed consent of the winner to use their name and image at no cost for advertising purposes, wherever the same are related to the present prize draw.
- 8.7 Furthermore, the winner shall release MANGO, and any of its group companies, associate companies or personnel of the same of any liability derived from any damages they may incur in the enjoyment of the prize referred to in the present prize draw.

9.- DATA PROTECTION

- 9.1 The personal details of prize draw entrants and winners will be treated in accordance with the current legislation. Said details will be included on a computerised file, under the ownership and responsibility of MANGO, and will be treated in a computerised manner for the purposes of managing the progress of the prize draw, the award of the prizes which are the object of the prize draw and/or the purpose of advertising or canvassing MANGO products which may be of interest to the same, including communications by electronic means.
- 9.2 MANGO shall establish the technical and organisational resources to guarantee the security of the computerised files, data treatment centres, premises, equipment, systems, programmes and persons involved in the computerised treatment of the personal details, in the manner envisaged in the applicable legislation.
- 9.3 Those affected may contact the database manager (PUNTO FA, S.L., Carrer Mercaders 9-11, Pol. Ind. Riera de Caldes, 08184 Palau-solità i Plegamans) in writing to exercise their rights of access, rectification, cancellation or opposition, or via the "Registration" section of www.mango.com.
- 9.4 Indication of the personal details of the winner shall be obligatory for the management of the prize. Any false notification of personal details shall entitle the organisers of the present prize draw to disqualify the winner, without prejudice to any other actions MANGO may adopt in this regard.

10.- TAX REGIME

The prize shall be subject to the applicable tax legislation.
